

Price indices of sold production of industry in September 2021

According to preliminary data, the prices of sold production of industry in September 2021 increased compared to August 2021 by 0.7 % and compared to that recorded in the corresponding month of the previous year - by 10.2%.

According to preliminary data, the prices of sold production of industry in September 2021 were higher by 0.7% compared to August 2021. The prices the most increased in the section manufacturing - by 0.8%. Different price changes were recorded in individual divisions of manufacturing. The prices the most increased in manufacture of coke and refined petroleum products (by 4.3%). The prices growth was recorded also, among others, in manufacture: of basic metals (by 1.8%), of leather and related products as well as of printing and reproduction of recorded media (by 1.3% each), of products of wood, cork, straw and wicker as well as of chemicals and chemical products (by 1.0% each), of metal products (by 0.9%), of wearing apparel (by 0.8%), of food products as well as of other transport equipment (by 0.7% each), of paper and paper products as well as of rubber and plastic products (by 0.6% each), of textiles as well as of other non-metallic mineral products (by 0.5% each), of electrical equipment (by 0.4%), of furniture (by 0.1%). The prices of manufacture of computer, electronic and optical products remained at the similar level to that recorded in the previous month. However, the prices decreased, among other things, in manufacture: of beverages as well as of motor vehicles, trailers and semi-trailers (by 0.1% each), of tobacco products as well as of machinery and equipment (by 0.2% each) and of pharmaceutical products (by 0.3%). The prices in the sections electricity, gas, steam and air conditioning supply as well as in water supply; sewerage, waste management and remediation activities increased respectively by 0.6% and by 0.1%. However, the prices drop was recorded in the section mining and quarrying - by 0.4%, of which in mining of metal ores - by 1.4%, with the prices growth in mining of coal and lignite - by 0.1%.

Among divisions of manufacturing in September 2021 the most increased the prices in manufacture of coke and refined petroleum products in comparison with the previous month as well as in annual terms

In September 2021 the prices of sold production of industry compared to September 2020 increased by 10.2%. The prices were higher than in the previous year in all sections of the industry. The prices the most increased in the section mining and quarrying by 14.9%, of which in mining of metal ores - by 27.5%, and in mining of coal and lignite by 5.3%. The prices in manufacturing increased by 10.6%, with multidirectional prices movements in individual divisions. The prices the most increased in manufacture of coke and refined petroleum products (by 68.6%). The prices were also higher than in the year before, among other things, in manufacture: of basic metals (by 42.6%), of products of wood, cork, straw and wicker (by 18.0%), of chemicals and chemical products (by 14.9%), of paper and paper products (by 10.4%), of metal products (by 10.1%), of rubber and plastic products (by 9.6%), of food products (by 6.6%), of computer, electronic and optical products (by 5.3%), of furniture (by 5.0%), of other non-metallic mineral products (by 4.6%), of textiles as well as of electrical equipment (by 3.7% each), of beverages (by 3.0%), of other transport equipment (by 2.5%), of leather and related products (by 1.6%), of motor vehicles, trailers and semi-trailers (by 1.4%) as well as of pharmaceutical products (by 0.4%). The prices of manufacture of machinery and equipment remained at the similar level to that recorded in the previous year. However, the prices decreased, among other things, in manufacture: of tobacco products (by 1.9%), of wearing apparel as well as of printing and reproduction of recorded media (by 2.5% each). The prices in the section electricity, gas, steam and air conditioning supply increased in annual term by 5.5% and in the section water supply; sewerage, waste management and remediation activities - by 3.9%.

Chart 1. Prices changes of sold production of industry in 2020-2021 in relation to the previous period






Chart 2. Prices changes of sold production of industry in 2020-2021 in relation to the same period of the previous year
