

# Price indices of sold production of industry and construction and assembly production in December 2018

18.01.2019

The drop of producer prices in industry in comparison to the previous month

According to preliminary data in December 2018 in comparison to November the prices of sold production of industry decreased by 0.9%. The prices of construction and assembly production were higher by 0.4%.

According to preliminary data in December 2018 the prices of sold production of industry were higher by 2.2% in comparison to December 2017. The prices increase was also recorded in construction and assembly production – by 3.7%. In the period January-December 2018 the prices of sold production of industry were higher by 2.1% in comparison to the corresponding period 2017 (when the growth was recorded – by 2.9%) and the prices of construction and assembly production increased by 2.7% (the growth in the previous year – by 0.6%).

The prices in industry in December 2018 in annual terms increased by 2.2%, in construction – by 3.7%.

In December 2018 in comparison to the previous month the drop of prices was recorded in sections mining and quarrying as well as in manufacturing. The growth of prices was recorded in sections electricity, gas, steam and air conditioning supply as well as in water supply; sewerage, waste management and remediation activities. Prices in all sections of industry increased in comparison to corresponding month of 2017 year.

#### The prices of sold production of industry

According to preliminary data in December 2018, the prices of sold production of industry were lower by 0.9% in comparison to the previous month. The drop of prices was recorded in manufacturing by 1.0% of which the biggest one was recorded in manufacture of coke and refined petroleum products (by 11.0%). The prices were also lower among other things in printing and reproduction of recorded media (by 0.8%), in manufacture: of chemicals and chemical products (by 0.7%), of wearing apparel (by 0.5%), of furniture (by 0.4%), of leather and related products, of pharmaceutical products, of basic metals (by 0.3% each), of products of wood, cork, straw, of metal products (by 0.2% each), of food products, of rubber and plastic products (by 0.1%). The prices of paper and paper products achieved the similar level to these recorded in the previous month. The growth of prices was recorded among other things in manufacture: of beverages, of computer, electronic and optical products (by 0.1% each), of other non-metallic mineral products, of machinery and equipment n.e.c. of motor vehicles, trailers and semitrailers (by 0.2% each), of electrical equipment (by 0.3%), of textiles, other transport equipment (by 0.4% each), of tobacco products (by 0.6%). The drop of prices was noted in mining and quarrying by 0.6% of which in mining of metal ores by 1.5% with the growth of prices in mining of coal and lignite by 0.1%. However, the prices increased in sections electricity, gas, steam and air conditioning supply as well as in water supply; sewerage, waste management and remediation activities by 0.1% each.

In December 2018 the prices of sold production of industry were higher by 2.2% than a year earlier. The biggest rise of prices was recorded in electricity, gas, steam and air conditioning supply by 3.1%. The prices in manufacturing increased by 2.2% of which in manufacture: of leather and related products (by 7.3%), of basic metals (by 5.6%), of paper and paper products ( by 4.9%), of other non-metallic mineral products (by 4.6%), of coke and refined petroleum products (by 3.8%), of chemicals and chemical products (by 3.7%), of textiles (by 3.1%), of beverages (by 2.9%), of metal products (by 2.5%), of products of wood, cork, straw and wicker (by 2.4%), of motor vehicles, trailers and semitrailers (by 2.3%), of pharmaceutical products (by 2.2%), of tobacco products (by 1.8%), of wearing apparel ((by 1.6%), of other transport equipment, of furniture (by 1.5% each), of machinery and equipment n.e.c (by 1.3%), of electrical equipment (by 1.2%), of rubber and plastic products (by 1.1%), of food products, of computer, electronic and optical products (by 0.5% each). The prices in printing and reproduction of recorded media remained at the similar level to these recorded a year earlier. The prices in section mining and quarrying increased by 1.5% of which in mining of coal and lignite by 3.2% with the drop in prices in mining of metal ores by 4.7%. The price growth was also recorded in section water supply; sewerage, waste management and remediation activities - by 1.5%.

The prices of construction and assembly production


The prices of construction and assembly production in December 2018 were higher by 0.4% than in the previous month. The growth of prices was recorded in civil engineering (by 0.5%), construction of buildings (by 0.4%) and specialised construction activities (by 0.2%).

In comparison to December 2017, the prices of construction and assembly production increased by 3.7% out of that the prices in construction of buildings (by 3.9%), in civil engineering (by 3.7%) as well as in specialised construction activities (by 2.8%).

In December 2018 in comparison to the previous month the biggest drop of prices was recorded in manufacture of coke and refined petroleum products by 11.0% (in comparison to December 2017 the price rise was 3.8%).

Prices in construction in December 2018 in annual terms increased in all divisions of construction.

■ price indices of construction and assembly production




Chart 3. Dynamics of prices of assembly and construction production in 2017-2018 (XII previous year = 100)





Chart 4. Dynamics of prices of sold production of industry sections in 2018 (XII previous year = 100)
