

Foreign trade turnover of goods in total and by countries in January - August 2021

Foreign trade turnover¹ in January – August 2021 in exports at current prices amounted to PLN 829.5 bn, while in imports - PLN 821.2 bn. The positive balance reached the level of PLN 8.3 bn, while in the same period of 2020 year amounted to PLN 23.2 bn. In comparison to the corresponding period of 2020 exports increased by 25.9%, while imports by 29.2%.

Foreign trade turnover expressed in US dollars and in EUR

Exports expressed in USD amounted to 219.4 bn, while imports amounted to USD 217.2 bn (an increase in exports of 32.1% and in imports of 35.5%). The positive balance reached the level of USD 2.2 bn, while in the same period of 2020 year amounted to USD 5.7 bn.

Exports expressed in EUR amounted to 182.5 bn, while imports amounted to EUR 180.7 bn (an increase in exports of 21.8% and in imports of 24.9%). The positive balance reached EUR 1.8 bn, while EUR 5.2 bn in the same period of 2020.

Foreign trade turnover of goods in total and by groups of countries

Poland has the largest share in total exports with the developed countries – 86.2% (of which EU 74.7%) and in imports – 63.5% (of which EU 54.9%), in comparison with 86.3% (of which EU 73.7%) and 65.3% (of which EU 55.4%) in the corresponding period in 2020 year. However, the smallest share was observed with the countries of Central and Eastern Europe, which in total exports amounted to 5.7%, and in imports – 7.6%, in comparison with 6.0% and 6.4% in the January – August 2020 period.

The negative balance was recorded with the developing countries – minus PLN 169.8 bn (minus USD 44.9 bn, minus EUR 37.4 bn) and with the countries of Central and Eastern Europe minus PLN 15.4 bn (minus USD 4.1 bn, minus EUR 3.4 bn). The positive balance was obtained in turnover with the developed countries PLN 193.5 bn (USD 51.2 bn, EUR 42.6 bn), of which with the EU countries the balance of PLN 168.9 bn (USD 44.7 bn, EUR 37.2 bn).

Note. Due to the rounding of data, in some cases sums of components may slightly differ from the amount given in the item "total".

Foreign trade turnover by major countries

After eight months of 2021 among the main trade partners of Poland a decrease both in exports and imports was not observed compared to the same period of the last year.

The turnover with the top ten of Polish trade partners in exports accounted for 65.0% (65.6% in the same period of the last year), while in total imports – 64.6% (in comparison with 64.1% in January – August 2020).

The share of Germany in exports increased in comparison with the corresponding period of the last year by 0.2 pp and amounted to 28.8% and in imports decreased by 0.4 pp and accounted for 21.3%. The positive balance amounted to PLN 64.0 bn (USD 16.9 bn, EUR 14.1 bn) in comparison with PLN 50.5 bn (USD 12.7 bn, EUR 11.4 bn) in the same period of 2020.

² Country of origin is the country where the commodity was produced or processed and in this form entered the Polish customs zone.

Imports by country of consignment – total and groups of counties

The highest turnover in imports by country of consignment Poland recorded with the developed countries - PLN 594.0 bn, of which with the EU - PLN 549.1 bn, compared to PLN 473.0 bn, of which with the EU - PLN 428.5 bn in the same period of 2020.

Imports by country of consignment – countries

The share of Germany in imports by country of consignment in comparison with imports by country of origin was higher by 5.3 pp, accordingly the share of the Netherlands was higher by 2.3 pp, Belgium by 1.3 pp, Czechia by 0.6 pp and France by 0.4 pp.

³ Country of consignment is the country from which the goods were introduced into the Polish territory irrespective of their origin.

After eight months of 2021 trade turnover in goods according to the SITC nomenclature compared to the same period of 2020 year, reported an increase in all commodity sections both in exports and imports.

In exports the largest increase concerned mineral fuels, lubricants and related materials (by 43.6%), animal and vegetable oils, fats and waxes (by 40.8%), crude materials inedible, except fuels (by 38.2%), machinery and transport equipment (by 30.4%), manufactured goods classified chiefly by material (by 29.0%), miscellaneous manufactured articles (by 25.6%), chemicals and related products (by 22.8%), food and live animals (by 11.3%), commodities and transaction not classified elsewhere in the SITC (by 2.6%) and beverages and tobacco (by 1.3 %).

In imports an increase was recorded in commodities and transaction not classified elsewhere in the SITC (by 126.6%), manufactured goods classified chiefly by material (by 39.4%), crude materials inedible, except fuels (by 36.3%), mineral fuels, lubricants and related materials (by 35.6%), chemicals and related products (by 29.9%), machinery and transport equipment (by 28.1%), animal and vegetable oils, fats and waxes (by 26.0%), miscellaneous manufactured articles (by 23.5%), beverages and tobacco (by 8.6%) and food and live animals (by 6.9%).

Chart 1. Composition of exports by sections according to SITC nomenclature in I - VIII 2021





Chart 2. Composition of imports by sections according to SITC nomenclature in I - VIII 2021
