**Foreign trade turnover of goods in total and by countries ¹
in January – October 2016**

From January to October of 2016, exports at current prices amounted to PLN 655286.4 mln, while imports amounted to PLN 636154.9 mln. The positive balance reached the level of PLN 19131.5 mln, while in the previous year PLN 8961.8 mln. In comparison to the corresponding period of the 2015, exports increased by 5.1% and imports by 3.5%.

Exports expressed in USD amounted to 168308.7 mln while imports amounted to USD 163369.5 mln (an increase in exports of 0.5% and in imports decline of 1.0%). The positive balance reached the level of USD 4939.2 mln (against USD 2427.6 mln from January to October 2015).

Exports expressed in EUR amounted to 150870.6 mln while imports amounted to EUR 146458.7 mln (an increase in exports of 0.8% and in imports decline of 0.8%). The positive balance reached the level of EUR 4411.9 mln compared to EUR 2135.7 mln in the same period last year.
