



Foreign trade turnover in total and by countries in 2014

In 2014, exports at current prices amounted to PLN 693471.6 mln, while imports amounted to PLN 704567.5 mln. The negative balance reached the level of PLN 11095.9 mln, while in 2013 minus PLN 8219.4 mln. In comparison to the 2013, exports increased by 7.0% and imports by 7.4%.

Exports expressed in USD amounted to 222339.4 mln while imports amounted to USD 225898.5 mln (an increase of 7.9% and 8.2% respectively). The negative balance reached the level of USD 3559.1 mln (against minus USD 2642,4 mln in the 2013).

Exports expressed in EUR amounted to 165773.6 mln while imports amounted to EUR 168432.3 mln (an increase in exports of 7.0% and in imports of 7.3% respectively). The negative balance reached the level of EUR 2658.7 mln compared to minus EUR 1984.0 mln in the 2013.
