**Foreign trade turnover of goods in total and by countries
in 2015**

In 2015 (according to final data), exports at current prices amounted to PLN 750835.8 mln, while imports amounted to PLN 740973.3 mln. The positive balance reached the level of PLN 9862.5 mln, compared to minus PLN 11095.9 mln in 2014. In comparison of 2014, exports increased by 8.3% and imports by 5.2%.

Exports expressed in USD amounted to 200342.8 mln while imports amounted to USD 197682.1 mln (a decline of 9.9% and 12.5% respectively). The positive balance reached the level of USD 2660.7 mln (against minus USD 3559.1 mln in 2014).

Exports expressed in EUR amounted to 179578.2 mln while imports amounted to EUR 177232.9 mln (an increase in exports of 8.3% and in imports of 5.2% respectively). The positive balance reached the level of EUR 2345.3 mln compared to minus EUR 2658.7 mln in 2014.
