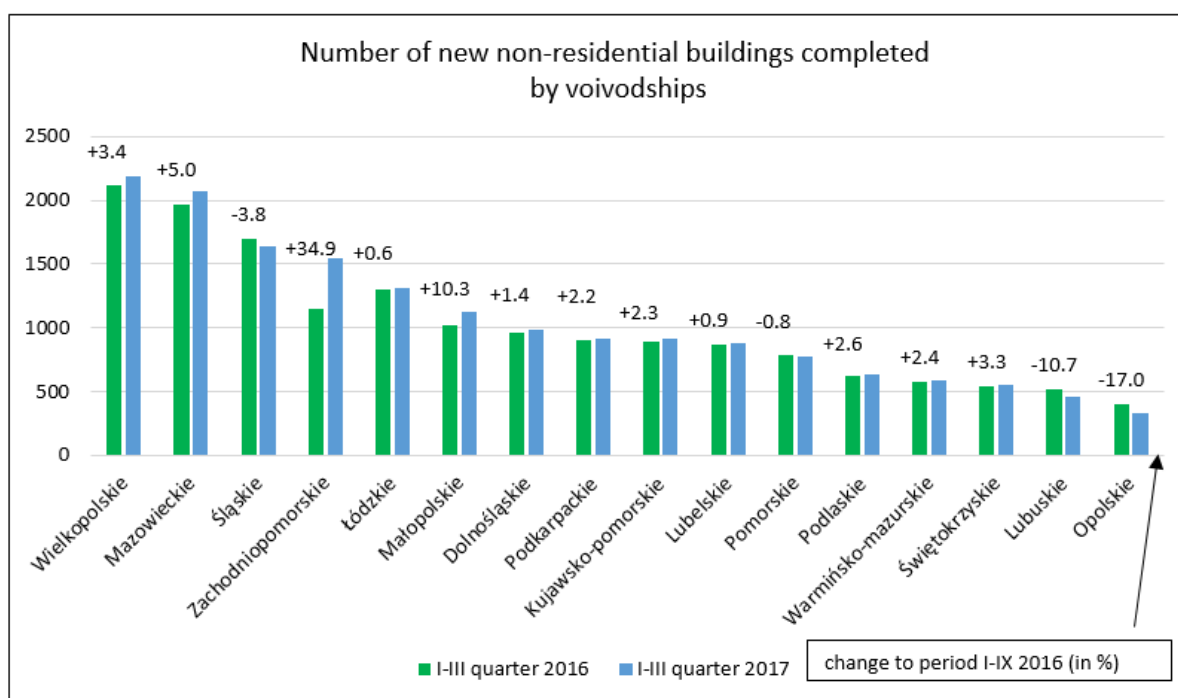


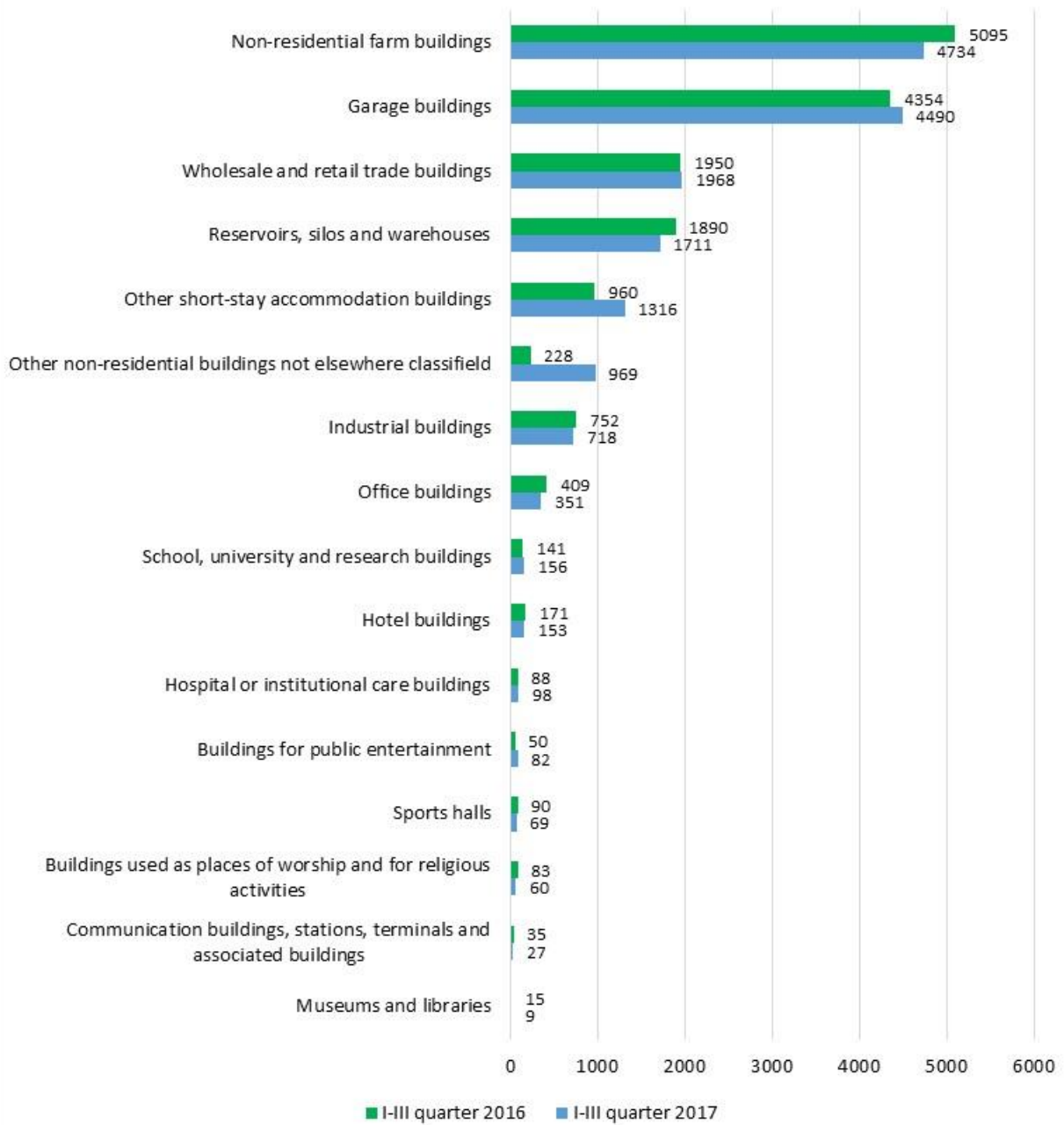
Non-residential construction in I-IX of 2017

In the period January-September of 2017, in comparison with corresponding period of the previous year, a growth of non-residential **buildings completed** was observed, while the number of **non-residential buildings for which permits have been granted or which have been registered with a construction project** decreased.



In the period of nine months of 2017 there were 16911 **new non-residential buildings completed** (by 3.7% more than a year before), while an increase, compared to January-September of 2016, was observed in twelve voivodships, of which the highest in: zachodniopomorskie – by 34.9% (to 1543 buildings), małopolskie – by 10.3% (to 1123 buildings) and mazowieckie – by 5.0% (to 2066). However, the largest decrease in the number of non-residential buildings completed was recorded in: opolskie voivodship – by 17.0% (to 332 buildings), lubuskie – by 10.7% (to 460), śląskie – by 3.8% (to 1633 buildings) and pomorskie – by 0.8% (780).

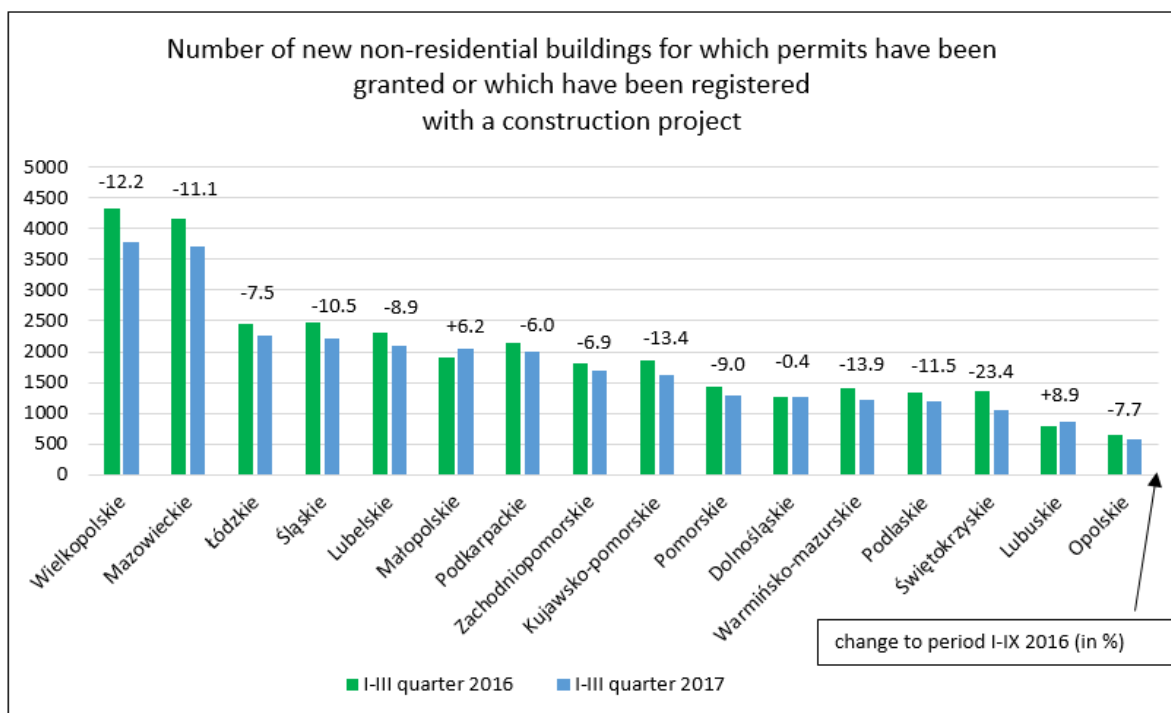
Number of new non-residential buildings completed by Polish Classification of Types of Construction



In the period of January-September of 2017 there were 16911 new non-residential buildings completed. The highest share among them was observed in: the non-residential farm buildings (28.0%), the garage buildings (26.6%) and the wholesale and retail trade buildings (11.6%), while a significant increase was observed in the public entertainment buildings – by 64.0% (to 82 buildings), the other short-stay accommodation buildings – by 37.1% (to 1316) and the hospitals and institutional care

buildings – by 11.4% (to 98). A decline in the number of new non-residential buildings completed was recorded in the museums and libraries – by 40.0% (to 9 buildings), the buildings used as places of worship and for religious activities – by 27.7% (to 60), the sports halls – by 23.3% (to 69) and the communication buildings, stations, terminals and associated buildings – by 22.9% (to 27).

The **cubic volume** of non-residential buildings, in I-IX of 2017, amounted to 84636 thous.m³ (a growth by 5.6% in comparison to nine months of 2016), while the cubic volume of **new buildings** amounted to 73313 thous. m³ (a growth by 4.6%) and expanded buildings (in the expanded portion) – 11323 thous. m³ (an increase by 12.5%). The highest growth of total cubic volume was recorded in: zachodniopomorskie voivodship – by 99.8%, opolskie – by 70.6%, lubelskie – by 46.4% and the lowest growth in: pomorskie – by 1.2% and mazowieckie – by 0.7%. The highest decline of the cubic volume was observed in dolnośląskie – by 18.4%, wielkopolskie – by 17.2% and lubuskie – by 8.5%.



In January-September of 2017 the number of new non-residential buildings **for which permits have been granted or which have been registered with a construction project** declined by 8.9% - to 28876 buildings (31680 in the I-III quarter of 2016). The increase of the number of buildings was recorded in two voivodships, of which in: lubuskie – by 8.9% (to 871 buildings) and małopolskie – by 6.2% (to 2037).

The largest decrease in the number of new non-residential buildings for which permits have been granted was observed in voivodships: świętokrzyskie - by 23.4% (to 1046 buildings), warmińsko-mazurskie - by 13.9% (to 1219) and kujawsko-pomorskie - by 13.4% (to 1611).
