


Financial results of cultural institutions in the period January-December 2020

23.03.2021



In 2020 financial results of cultural institutions were lower compared to results in the same period of the previous year. Total revenues decreased by 5.3% and total costs by 5.9% but investment outlays increased by 1.2%.

Total revenues (revenues from the whole activity) of cultural institutions in 2020 were 5.3% lower than revenues generated in the previous year and amounted to 9 661.0 million PLN. The structure of the revenues was composed of: net revenues from sales of products, goods and materials (90.6%), other operating revenues (9.3%) and financial revenues (0.1%). The highest total revenues were generated by institutions in Mazowieckie Voivodship (27.2% share).

Total costs (costs of obtaining revenues from the whole activity) in 2020 were 5.9% lower than in the previous year and amounted to 9 465.8 million PLN. The structure of these costs was composed of: operating costs (98.8%), other operating costs (1.1%), financial costs (0.1%). As in case of total revenues, the highest total costs were incurred by units from Mazowieckie Voivodship (27.1%).

National cultural institutions achieved total revenues of 1 919.8 million PLN, while total revenues of local government units amounted to 7 741.2 million PLN (in 2019: 1 813.8 million PLN and 8 390.1 million PLN, respectively).

Gross financial result amounted to 195.2 million PLN (profit 263.2 million PLN, loss 68.0 million PLN).


Net financial result amounted to 194.1 million PLN (136.8 million PLN in the previous year), with an increase of net profit (by 20.8%) and decrease of net loss (by 15.0%).

In 2020 investment outlays of cultural institutions amounted to 1 463.0 million PLN and were 1.2% higher compared to the previous year. The greatest share in investment outlays had cultural institutions in Mazowieckie Voivodship (25.7%).

Total revenues of gminas local cultural institutions in 2020 amounted to 5 381.9 million PLN

Net financial result of cultural institution in 2020 amounted to 194.1 million PLN Investment outlays incurred by local government cultural institutions amounted to 1 118.3 million PLN, i.e 76.4% of the total amount of investment outlays

Chart 1. The structure of investment outlays of cultural institutions by legal forms in 2020



Outlays on intangible fixed assets decreased in comparison to 2019 by 10.3% and amounted to 33.4 million PLN. The greatest share in outlays on intangible fixed assets had units from Mazowieckie Voivodship (52.5%).
