





# Number of persons at non-working age per 100 persons at working age







# International migration of population for permanent residence thousand of persons








### Students of higher education institutions by narrow field of education in the 2020/21 academic year





















# Persons who received health care benefits in 2020 within the State Emergency Medical Services by the place of occurrence (during the year)<sup>a</sup>




### Blood donors per 10 thousand population in 2020





### Structure of household expenditure on culture in 2021







### Structure of intramural expenditures on R&D (current prices)



### Directions of geodesic land use in 2021








# Structure of agricultural market output by products (current prices)









# Structure of construction and assembly production<sup>a</sup> by type of constructions (current prices)







# Foreign trade turnover by groups of countries in 2021 (current prices)









### Gross domestic product per capita (current prices)







### Structure of GDP generation in 2021 (current prices)










### Employment rate on the basis of LFS in 2021 (annual averages)




### Unemployment rate on the basis of LFS in 2021




### Average monthly available income per capita in households in 2021




Average monthly expenditure per capita in households in 2021




Non-financial sector enterprises equipping their employees with portable devices enabling mobile access to the Internet in 2021



Gross domestic expenditure on research and development activity per capita in 2020 (current prices)




