

## Information on entities of the national economy entered in the REGON register - December 2021



As at the end of December 2021 the REGON register included 4 836.2 thous. of national economy entities, i.e. by 0.2% more than a month before (by 3.7% more than in the corresponding period of the previous year).

An increase in the number of newly registered entities was recorded for companies by 32.7% including civil partnerships by 56.4% as well as commercial companies by 31.1%. The number of newly registered natural persons conducting economic activity has decreased

by 0.2% in relation to the previous month.

In December, 32.7% more entities were deregistered from the REGON register than a month ago. An increase in the number of deregistered entities in compare to the previous month was recorded for natural persons conducting economic activity (by 34.6%) and companies (by 17.5%).

Entities with suspended activity as at the end of December 2021 accounted for 11.6% of the total number of registered entities in the REGON register.


Taking into account the Nace sections an increase in the number of entities with suspended activity compared to the previous month recorded in sections of mining and quarrying (4.1%), construction (3.1%), administrative and support service activities (2.6%) and arts, entertainment and recreation activities (2.6%).

Territorially, in all voivodships there was an increase in the number of entities with suspended activity compared to the previous month. The largest increase in the number of entities with suspended activity in relation to the previous month was recorded in the following voivodships: lubelskie (by 2.5%), lubuskie (by 2.4%), kujawsko-pomorskie (by 2.2%).

An increase in the number of deregistered civil partnerships by 48.9% in relation to the previous month


Growth of entities with suspended activitiy by 1.6% in relation to the previous month


