

# Information on entities of the national economy entered in the REGON register - September 2022

An increase in the number of newly registered entities in relation to the previous month

As at the end of September 2022 the REGON register included 4 957.6 thous. of national economy entities, i.e. by 0.4% more than a month before (3.4% more than in the corresponding period of the previous year).

## Newly registered entities in the REGON register

An increase in the number of newly registered entities was recorded for natural persons conducting economic activity (by 8.0%) compared to the previous month. Natural persons conducting economic activity accounted for 81.4% of all newly registered entities in the REGON register. The number of newly registered companies increased (by 7.7%), including limited liability companies (by 6.1%) in relation to the previous month.

An increase in the number of newly registered civil partnerships by 26.9% in relation to the previous month

## Deregistered entities from the REGON register

In September, 13.7% more entities were deregistered from the REGON register in relation to the previous month. An increase in the number of deregistered entities was recorded for companies (by 28.4%) and natural persons conducting economic activity (by 9.3%) compared to the previous month.

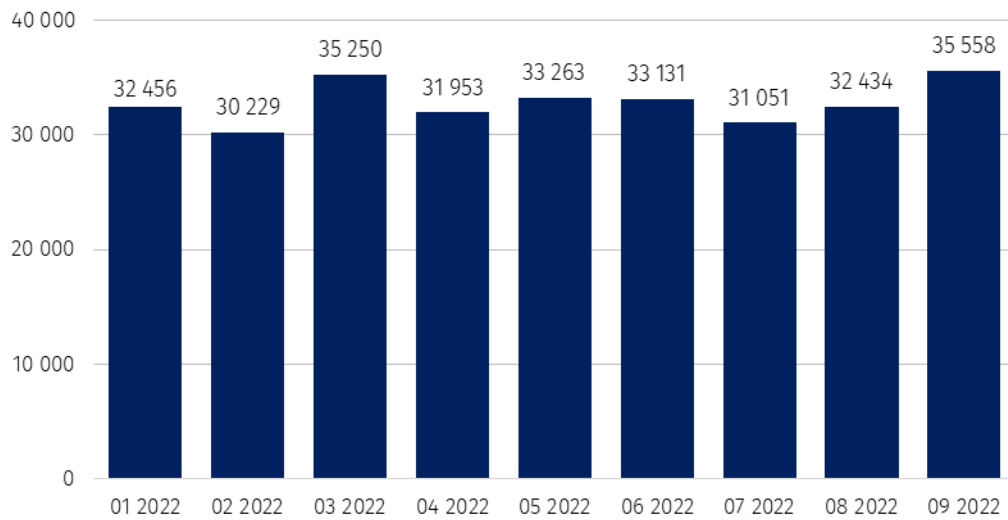
An increase in the number of deregistered commercial companies by 33.7% in relation to the previous month

## Entities with suspended activity in the REGON register

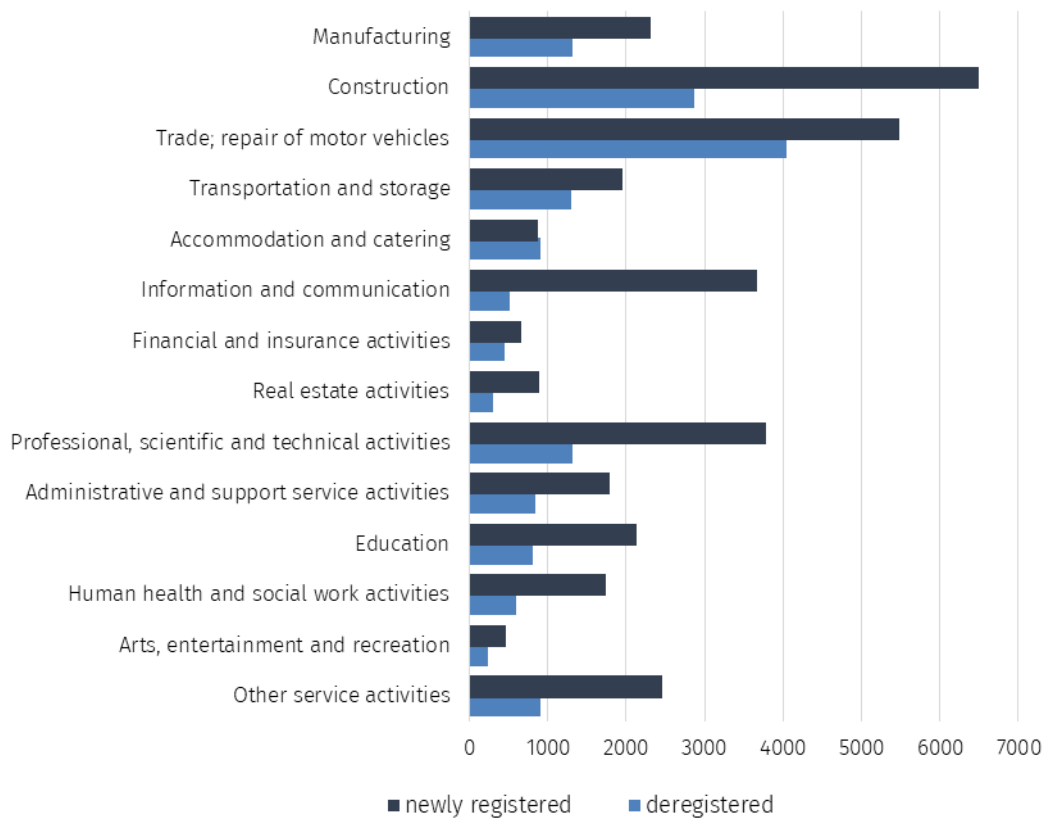
Entities with suspended activity as at the end of September 2022 accounted for 12.6% of the total number of registered entities in the REGON register. An increase in the number of entities with suspended activity compared to the previous month was noted in section of accommodation and catering (by 38.4%), real estate activities (by 1.9%), administrative and support service activities (by 1.9%).

An increase in the number of entities with suspended activity by 1.2% in relation to the previous month

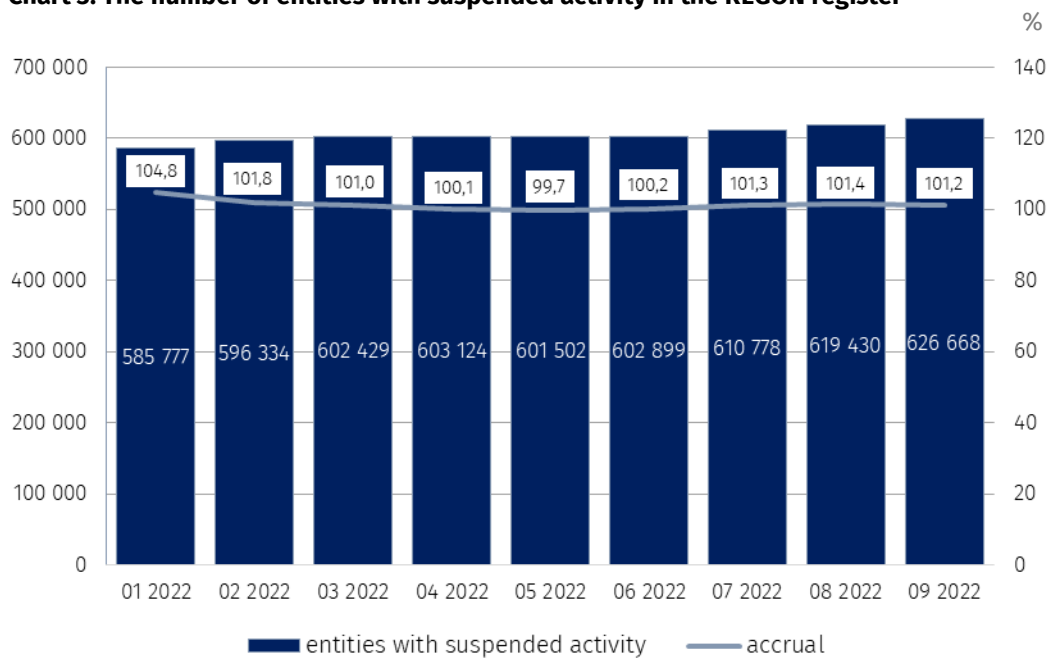
**Chart 1. The number of newly registered entities entered in the REGON register**
